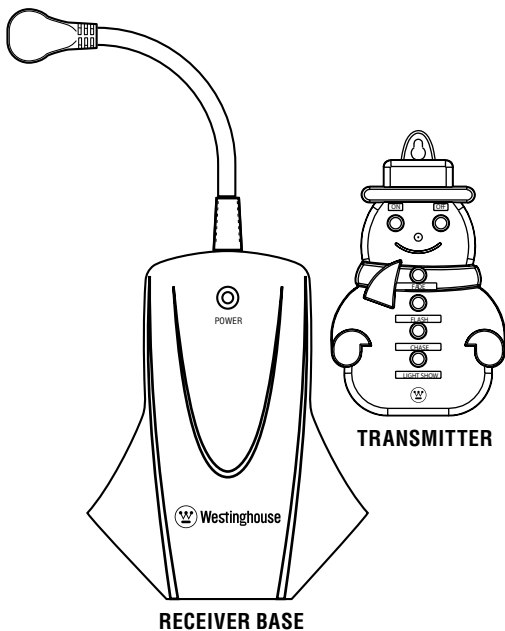




## F/X LIGHT SHOW REMOTE HUB

## INSTRUCTIONS

1. Insert the receiver base's 3-prong plug into a grounded outlet.
2. Plug light sets into the 3 outlets on the receiver base. Do not plug more than 250W of lights into any one outlet of the receiver base. If watts are not marked on your light string, multiply the ampere rating by 125 to determine equivalent watts.
3. Using the snowman ornament transmitter, press the corresponding button to activate the desired light and music effects.
4. Excessive switching between effects may cause the receiver to stop responding. If this occurs, simply turn off the remote to reset its internal computer chip, wait a few moments, and then turn the unit back on.

## FEATURES EXPLAINED

<b>ON / OFF</b>	All 3 outlets are steady on, with no special effects
<b>FADING</b>	3 outlets gradually turn on & off in a random fading pattern
<b>CHASING</b>	3 outlets illuminate on & off one at a time in sequence to create a chasing effect
<b>FLASHING</b>	3 outlets rapidly turn on & off for a flashing effect
<b>LIGHT SHOW</b>	Continuously runs through the above effects including steady on

## BATTERY REPLACEMENT:

The snowman ornament transmitter uses a 3V CR2032 battery, which is included. To replace the battery, slide off the battery cover on the back of the transmitter. Insert a new 3V CR2032 battery, making sure to match up to the + and - polarity markings. To test, press the ON and OFF buttons to make sure that the LED lights up. Slide the battery cover back on. Do not dispose of old batteries in fire. Batteries may explode or leak. Check with local regulations on the proper disposal of spent batteries.
